HARISPATTUWA PRADESHIYA SABHA

Imposing Assessment Tax for the year 2014

IT is hereby notified to the General Public that the Harispattuwa Pradeshiya Sabha has moved the following resolution under Motion number 09 (ii), in the General Session, held on the 27th of September, 2013.

- (a) By virtue of power vested under sub-Section (1) of the Section 146 of Pradeshiya Sabha Act, No. 15 of 1987, the Harispattuwa Pradeshiya Sabha is hereby propose to amend the proposal No. 08 (15), adopted on the 22nd of August 2013, to impose and levy Assessment Tax on every immovable property for the year 2014, situated within the Harispattuwa Pradeshiya Sabha administrative limits, in the areas as declared as developed.
- (b) By virtue of power vested under sub-section (1) of the Section 146 of Pradeshiya Sabha Act, No. 15 of 1987, hereby decide to accept the annual value of the immovable properties situated within the Harispattuwa Pradeshiya Sabha administrative limits, in the areas as declared as developed, under sub-Section 134 (1) of the Pradeshiya Sabha Act, No. 15 of 1987, prevailed in the year 2013 as the annual value of the year 2014 and to enforce the new Assessment Tax from 01.01.2014.
- (c) It is also decided to impose and levy an Assessment Tax on every immovable property situated in the streets and roads declared as developed areas within the administrative limits of Harispattuwa Pradeshiya Sabha, mentioned in the following Schedules No. I, II and III at the percentages of 10%, 6% and 4% respectively for the year 2014, in terms of sub-Section (1) of the Section 134 and,



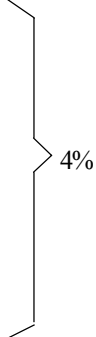
- (d) Furthermore, it is hereby proposed in terms of sub-Section (6) of Section 134 to levy the tax imposed for the year 2014, should be paid in 04 quarters in equal 04 installments, ending on 31st March, 30th June, 30th September and 31st December 2014, to the Pradeshiya Sabha office, respectively.

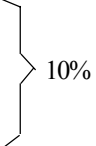

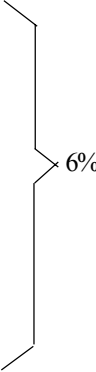
