THE LAND ACQUISITION ACT (CHAPTER 460)

Declaration under Section 5

I, Janaka Bandara Thennakoon, Minister of Lands and Land Development hereby give notice under Sub-section (1) of Section 5 of the Land Acquisition Act that the land described below is intended to be acquired for the construction of bore-holes at the Chilaw Water Supply Project under Asian Development Bank's donation under the provisions of that Act.

An allotment of land called as Sri Pushparama Vihara land *alias* Munneswaram Pansal land in extent of about 0.0127 Hectare depicted in Advance Tracing No. PU/CHL/2013/085 dated 23.04.2013 prepared by the Surveyor - General, situated at Munneswaram Village in Munneswaram Pattu Minor Division in Divisional Secretary's Division of Chilaw in Puttalam District in Northwestern Province and bounded as follows:

Declaration under Section 5
