Provincial Councils Notifications

ORDER PERTAINING TO ASSIGNING THE POWERS OF WESTERN PROVINCE PROVINCIAL PUBLIC SERVICE UNDER CLAUSE 32 OF PROVINCIAL COUNCILS ACT, No. 42 OF 1987 AMENDED BY PROVINCIAL COUNCILS (AMENDMENT) ACT, No. 28 OF 1990

I, Seyed Alavi Mowlana, the Governor of the Western Province, as per powers entrusted in me under Clause No. 32 of Provincial Councils Act, No. 42 of 1987 amended by Provincial Councils (Amendment) Act, No. 28 of 1990, subjected to enforcing by myself the powers related to appointment, transfer (including release from position of officers in positions of the Western Province Provincial Public Service as described in schedule 01 below and appointment, transfer (including release from position) of officers of the Western Province Provincial Public Service as described in schedule 02 below, shall hereby assign; having exempted the aforesaid powers the other powers (to the extent of relevance) related to disciplinary control and dismissal from service related to the said schedules of 01 and 02 including powers related to appointment, transfer, dismissal from service and disciplinary control ; to the Western Province Provincial Public Service Commission with effect from 31st of March 2014.

Further, it shall hereby be prescribed and declared that any party dissatisfied with the implementation of powers assigned thus, by the Western Province Provincial Public Service Commission except in an occasion where Western Province Provincial Public Service Commission implements powers related to disciplinary control and dismissal from service with regard to positions stated in schddule 02 below, has the right to appeal to the Governor of the Western Province. Moreover, when implementing powers by the Western Province Provincial Public Service Commission according to the powers stated under Sub-clause 32(2) (a) in the Provincial Councils Act, No. 42 of 1987 amended by Provincial Councils (Amendment) Act, No. 28 of 1990, unless any order is specifically made by me related to such powers, permission shall hereby be granted to assign those powers to the Chief Secretary of the Werstern Province or certain officer as the Western Province Provincial Public Service Commission decides.

In addition to that the order dated June 10 of 2013 pertaining to assigning of powers related to Western Province Provincial Public Service as announced by me in the Extraordinary Gazette Notification of the Democratic Socialist Republic of Sri Lanka under No. 1815/12 dated 20th June 2013 that has been enforced prior to assigning of these powers, shall hereby be repealed without any prejudice to actions taken under the said order.
