**STATUTE REGARDING THE UVA PROVINCIAL "GOVERNOR'S FUND" No.OF 2014 FOR FURTHER
AMENDMENTS TO THE UVA PROVINCIAL "GOVERNOR'S FUND" No. 03 OF 2003**

Be it enacted by the Uva Provincial Council of the Democratic Socialist Republic of Sri Lanka.

01. This Statute may be cited as the Uva Governor's Fund (Amendment), Statute No.....of 2014
and shall come into operation on such date as may be approved by the Governnor of Uva Province.

02. The Board of the Governor's Fund (herein after referred to as The Board) shall consists of :

- (a) The Governor of Uva Province ;
- (b) The Chief Minister of Uva Province ;
- (c) The Chairman of Uva Provincial Council ;



- (d) Leader of the opposition or a representative named by the Leader of the opposition of Uva Provincial Council ;
- (e) The Chief Secretary - Uva Province ;
- (f) The secretary to the Governor - Uva Province ;
- (g) Three others appointed by the Governor of the Uva Province for a period of time mentioned in such letters of appointment subject to conditions appearing in Sub-section 3 and 4. Out of the above 3 officers two should be an Accountant and a Attorney-at-Law.

Is amended and substituted as

- (a) The Governor of Uva Province ;
- (b) The Chief Minister of Uva Province or representative named by him ;
- (c) The Chairman of Uva Provincial Council ;
- (d) Opposition Leader of the Uva Provincial Council or representative named by him ;
- (e) The Chief Secretary - Uva Province ;
- (f) The secretary to the Governor - Uva Province ;
- (g) Provincial Director to the Health Service or a representative named by him. ;
- (h) Provincial Director to the Education of Uva Province or a representative named by him ;
- (i) According to the wishes of the Governor of Uva Province, Additional three members should be appointed which will include an Accountant and an Attorney-at-Law. Members should perform their functions for a period mentioned in the letter of appointment by the Governor of Uva Province subject to conditions appearing in Sub-section 3 and 4.

Sinhala text to prevail in event of inconsistency.

03. "In the event of any inconsistency between the Sinhala and Tamil text of this Statute, the Sinhala text shall prevail".
