### Land Acquisition Notices

#### THE LAND ACQUISITION ACT (CHAPTER 460)

##### Declaration under Section 5

I, Janaka Bandara Thennakoon, Minister of Lands and Land Development hereby declare, under Sub-section (1) of Section 5 of the Land Acquisition Act, that the Government intends to acquire the following lands which are required for the purpose of constructing Magalle right hand canal of Deduru Oya Project.

The allotments of land in total extent of about 5.5913 Hectares in Surveyor-General's Tracing No. KU/RSN/2012/114 and dated 03rd April, 2012, situated in the Villages of Nammuwawa (FVP 2397), Landawatta (FVP 2396A), Polontalawa (FVP 2369), Kadigawa (FVP 2395) in Magul Medagan Dahe Korale (West) Minor Division in Divisional Secretariat of Rasnayakapura in Kurunegala District in North Western Province and bounded as follows:

##### 01. Lot 'B' – Koongahamulahena Palugamehena Pathalagawa yaya – Extent: About 0.3420 Hectare

North: Koongahamulahena Palugamehena Pathalagawa yaya claimed by K. D. A. **19. Lot ‘AI’ – Haminnagamahena – Extent: About 0.1728 Hectare**
