**FILLING OF A VACANCY IN THE OFFICE OF A MEMBER OF THE
VALIKAMAM SOUTH PRADESHIYA SABHA UNDER SECTION 65A(2) OF THE LOCAL
AUTHORITIES ELECTIONS ORDINANCE (CHAPTER 262) AS AMENDED BY LOCAL AUTHORITIES

WHEREAS the office of a member in Valikamam South Pradeshiya Sabha has fallen vacant by reason of not attending meetings of the Council for a period of three months without premission ;

And whereas the Secretary of the recognized political party namely Ilankai Tamil Arasu Kadchi, to which the member Vasanthanathan Sivanathan belonged, was required by me under Section 65A(2) of the aforesaid Ordinance, to nominate within a period of thirty (30) days a person eligible under the Ordinance for Election as a member of that Valikamam South Pradeshiya Sabha who shall be declared elected as a member ;

And whereas the Secretary of the aforesaid recognized political party has failed to make a nomination within the period specified ;
