**FILLING OF A VACANCY IN THE OFFICE OF CHAIRMAN OF THE  
VALIKAMAM SOUTH WEST PRADESHIYA SABHA UNDER SECTION 65A(1) OF THE LOCAL  
AUTHORITIES ELECTIONS ORDINANCE (CHAPTER 262) AS AMENDED BY LOCAL AUTHORITIES
