### Notices under the Local Authorities Elections Ordinance

**FILLING OF A VACANCY IN THE MEMBER OF THE KELANIYA PRADESHIYA SABHA  
UNDER SECTION 65A (2) OF THE LOCAL AUTHORITIES ELECTIONS ORDINANCE (CHAPTER 262)  
AS AMENDED BY LOCAL AUTHORITIES (SPECIAL PROVISIONS) ACT, No. 30 OF 2013**

WHEREAS the office of a member in Kelaniya Pradeshiya Sabha has fallen vacant by reason of being ceased to be a member of the party :

And whereas the Secretary of the recognized political party namely People's Liberation Front to which Abeynayake Don Sanjaya Sujeewa belonged was required by me under Section 65A(2) of the aforesaid Ordinance, to nominate within a period of thirty (30) days a person eligible under the Ordinance for Election as a member of that Kelaniya Pradeshiya Sabha who shall be declared elected as a member.
