#### FILLING OF A VACANCY IN THE MEMBER OF THE YAKKALAMULLA PRADESHIYA SABHA UNDER SECTION 65A (2) OF THE LOCAL AUTHORITIES ELECTIONS ORDINANCE (CHAPTER 262) AS AMENDED BY LOCAL AUTHORITIES (SPECIAL PROVISIONS) ACT, No. 30 OF 2013

WHEREAS the office of a member in Yakkalamulla Pradeshiya Sabha has fallen vacant by reason of resignations ;

AND WHEREAS the Secretary of the recognized political party namely United National Party, to which the member Mr. Kananke Liyanage Sumanasiri belonged, was required by me under Section 65A(2) of the aforesaid Ordinance, to nominate within a period of thirty (30) days a person eligible under the Ordinance for elections as a member of that Yakkalamulla Pradeshiya Sabha who shall be declared elected as a member ;
