#### SABARAGAMUWA PROVINCIAL COUNCIL

Notification under the Section 185 of the Pradeshiya Sabha Act No.15 of 1987 read with Section 02 of the Provincial Council (Consequential Provisions) Act, No.12 of 1989 and Section 02 of the Powers of Supervision of the Administration of Local Authorities Statute No.06 of 1989

I, Maheepala Herath, Chief Minister and Minister of Law and Order, Finance and Planning, Local Government, Health and Indigenous Medicine, Women Affairs, Co-operatives, Trade and Food, Transport and Estate Welfare, Environment, News, Housing and Construction of the Sabaragamuwa Province, do hereby appoint the retired Judicial Officer, retired High Court Judge Hon. Saman Wickrama Wickramarachchi, as a single person tribunal of inquiry as per the powers vested in me by the provisions of Section 2(2) of the Powers of Supervision of the Administration of Local Authorities Statute No.06 of 1989 of the Sabaragamuwa Provincial Council to inquire and submit a report based on the matters under Section 2(1) of the aforementioned statute, regarding functions of the Chairman of the Mawanella Pradeshiya Sabha of the Kegalle District, Mr. P.P. Wickramasinghe.

02. I, Maheepala Herath, Chief Minister and Minister of Law and Order, Finance and Planning, Local Government, Health and Indigenous Medicine, Women Affairs, Co-operatives, Trade and Food, Transport and Estate Welfare, Environment, News, Housing and Construction of the Sabaragamuwa Province, do hereby suspend with immediate effect, Mr. P.P. Wickramasinghe, Chairman of the Mawanella Pradeshiya Sabha of the Kegalle District, functioning as the Chairman of the aforesaid Pradeshiya Sabha, as per the powers vested in me by the provisions of Section 03 of the Powers of Supervision of the Administration of Local Authorities Statute No.06 of 1989 of the Sabaragamuwa Provincial Council.

03. As the functions of Mr.P.P. Wickramasinghe as the Chairman of the Mawanella Pradeshiya Sabha has been suspended with immediate effect under the provisions of Section 185 of the Pradeshiya Sabha Act, No.15 of 1987 read with the Provincial Council (Consequential Provisions) Act, No.12 of 1989 and Section 03 of the Powers of Supervision of the Administration of Local Authorities Statute No.06 of 1989, I do hereby order Mr. Mohomed Sally Mohomed Kamel, Deputy Chairman of the Mawanella Pradeshiya Sabha to execute the powers and carry out the tasks thereof, under the Section 3 (a) (i) of the Powers of Supervision of the Administration of Local Authorities Statute No.06 of 1989 and Section 185 of the Pradeshiya Sabha Act No.15 of 1987.
