THE LAND REFORM LAW, No. 1 OF 1972

Order under Subsection (4) of Section 27 A

BY VIRTUE of the powers vested in me by Section 27 A (4) of the Land Reform Law, No. 1 of 1972 as amended by the Land Reform (Special Provisions) Act, No. 39 of 1981, read with Article 44 (2) of the Constitution of the Democratic Socialist Republic of Sri Lanka, I, Mahinda Rajapaksa, President, do hereby –

(a) amend the Order made under section 27A (1) of the Land reform Law, No. 1 of 1972, and published in *Gazette Extraordinary* No. 181/12 of February 27, 1982 relating to the land called and known as Lelwala Watta morefully described in the First Schedule to this Orderr and which has been vested in the Sri Lanka State Plantations Corporation established under the Sri Lanka State Plantations Corporation Act, No. 4 of 1958, by revoking on grounds of non-compliance with such terms and conditions relating to consideration for the vesting in such Corporation, such portion of the said Order as relates to the extent of land called Lelwala Watta specified in the Second Schedule hereto ; and

(b) state that upon revocation, such extent of land shall re-vest in the Land Reform Commission.
