THE LAND ACQUISITION ACT (CHAPTER 460)

Declaration under Section 5

I, Janaka Bandara Thennakoon, Minister of Lands and Land Development hereby declare, under Sub-section (1) of Section 5 of the Land Acquisition Act, that the lands described below are needed for Re-construction of Ingiriya - Halwathura - Egaloya Road No. 5/4 Bridge and will be acquired under the provisions of that Act.

The Allotments of land in total Extent of About 0.1710 Hectare, prepared by the Surveyor-General's Tracing No. KA/RDA/2013/522P and dated 27th December, 2013, situated in the Villages of Halwathura and Bothale in the Divisional Secretary's Division of Bulathsinhala in Kaluthara District in Western Province and bounded as follows:
