### Land Acquisition Notices

#### THE LAND ACQUISITION ACT (CHAPTER 460)

##### Declaration under Section 5

I, Janaka Bandara Thennakoon, Minister of Lands and Land Development hereby declare, under Sub-section (1) of Section 5 of the Land Acquisition Act, that the lands described below are needed for a public purpose and will be acquired under the provisions of that Act.

Three (03) allotments of land, depicted in Advance Tracing No. P.P.MAHA 5504 and dated 12th October, 2003, prepared by Surveyor-General, situated in the Village of Asgiriya (Ward No. 06, Asgiriya within the limits of Kandy Municipal Council) in the Minor Division of Gangawata Korale in the Divisional Secretary's Division of Kandy and Gangawata Korale in Kandy District, Central Province and bounded as follows:

**01. Lot No. 03 – Welikandahena – Extent: 0.0022 Hectare**
