Provincial Councils Notifications

NORTHERN PROVINCE PROVINCIAL COUNCIL

THE Notification made under Section 255 of the Urban Council Ordinance, No. 67 of 1939 read with Section 2 of the Provincial Councils (Consequential Provisions) Act, No. 12 of 1989.

2. I, C. V. Wigneswaran, the Chief Minister and the Minister of Finance and Planning, Law and Order, Lands, Road Development, Electricity, Housing and Construction, Water Supply, Co-operative Development, Social Service and Rehabilitation, Women's Affairs, Industries and Enterprise Promotion, Tourism, Local Government and Provincial Administration and Food Supply and Distribution of Northern Province, by virtue of powers vested in me under sub-section (1) of the Section 184 (Chapter 255) of the Urban Council Ordinance, No. 67 of 1939 read with Section 2 of the Provincial Council (Consequential Provisions) Act, No. 12 of 1989, have appointed Mr. Kandiah Ariyanayakam, the retired District Court Judge, to an individual commission to submit the report by investigating activities of Valvettiturai Urban Council, regarding the following matters/ charges under the sub-section 184 (1B) (a) (Chapter 255) of the Urban Council Ordinance No. 67 of 1939.

Matters/ Charges to be investigated :-

- (i) Council was made stagnant by the decision of council meeting ;
- (ii) Persistent refusal to hold or attend meetings or to transact business at any meetings that may be held ;
- (iii) Wilful neglect or misconduct in the performance of the duties imposed by this Ordinance ;
- (iv) Incompetence and mismanagement ;
- (v) Abuse of the power conferred by this Ordinance.



03. I, C. V. Wigneswaran, the Chief Minister and the Minister of Finance and Planning, Law and Order, Lands, Road Development, Electricity, Housing and Construction, Water Supply, Co-operative Development, Social Service and Rehabilitation, Women's Affairs, Industries and Enterprise Promotion, Tourism, Local Government and Provincial Administration and Food Supply and Distribution of Northern Province, by virtue of powers vested in me under sub-section (1) (1B) (a) (iii) of Section 184 (Chapter 255) of the Urban Council Ordinance, No. 67 of 1939 read with Section 2 of the Provincial Council (Consequential Provisions) Act, No. 12 of 1989, do hereby suspend the functions of Valvettiturai Urban Council in Jaffna District with immediate effect. I do hereby order Mr. Constantine Jackseel, the Regional Assistant Commissioner of Local Government of Jaffna District to execute the power and carry out the tasks thereof.
