FILLING OF A VACANCY IN THE OFFICE OF A MEMBER OF THE KARACHCHI PRADESHIYA SABHA UNDER SECTION 65A(2) OF THE LOCAL AUTHORITIES ELECTIONS ORDINANCE (CHAPTER 262) AS AMENDED BY LOCAL AUTHORITIES (SPECIAL PROVISIONS) ACT, No. 30 OF 2013

WHEREAS the office of a member in Karachchi Pradeshiya Sabha has fallen vacant by reason of not attending meetings of the Council for a period of three months without permission ;
