##### THE LAND ACQUISITION ACT, (CHAPTER 460)

###### Notice under Section 7

*My Ref. No.:* KDS/KUN/04/07/16/04/53.

I, hereby give notice, under Sub-section (1) of section 7 of the Land Acquisition Act, that the Government intends to acquire the following land/servitude which is required for a public purpose.

###### *Description of the land or Servitude to be acquired:*

The allotment of land called “Gallenagodahena” in total extent of about 0.0128 Hectares, depicted as Lot No. 1 in the Preliminary Plan, No. Maha 6231 dated 27.06.2014, surveyed and prepared by the Surveyor General, situated at the village of Gunnepana in Udagampaha Korale Minor Division in the Divisional Secretary’s Division of Kundasale in Kandy District, Central Province and bounded as follows.
