THE STATE INDUSTRIAL CORPORATION ACT, No. 49 OF 1957 OF CHAPTER 208

Order under Section 25

BY virtue of the powers vested in me, by Section 25 of the State Industrial Act, No. 49 of 1957 of chapter 208, I, Nambukara Helambage Rajitha Harischandra Senaratne, Minister of Fisheries and Aquatic Resources Development, do hereby, with the concurrences of the Minister of Finance and Planning and the Minister of Land and Land Development, transfer to the Ceylon Fisheries Corporation, which was established by Incorporation Order made under Section 2 of the aforesaid Act and published in Gazette Extraordinary No. 14,186 of October 1st, 1964, the immovable property of the crown specified in the Schedule hereto.
