#### DECLARATION OF GAMPOLA NIYAMGAMPAYA RAJAMAHA VIHARA SACRED AREA AS SACRED AREA ORDER PUBLISHED IN EXTRAORDINARY GAZETTE NOTIFICATION No.1681/3 OF 22<sup>ND</sup> NOVEMBER 2010

I, Dr.Dissanayake Mudiyansele Jayaratne as the Honourable Minister of Buddhasasana and Religious Affairs by According to the subject matter of sacred area planning and development vested in me, as per the notification issued by His Excellency the President of Democratic Socialist Republic of Sri Lanka Mr.Mahinda Rajapaksa by the Extraordinary Gazette of the Democratic Socialist Republic of Sri Lanka No.1681/3 of 22<sup>nd</sup> November 2010, declared that, the land area depicted clearly in the schedule as a sacred area and it shall be cited as "Gampola Niyamgampaya Rajamaha Viharaya sacred area", for its long-term security.
