DECLARATION OF NUWARA ELIYA ST. FRANCIS SAVIOUR CHURCH SACRED AREA AS SACRED AREA ORDER PUBLISHED IN EXTRAORDINARY GAZETTE NOTIFICATION No.1681/3 OF 22ND NOVEMBER 2010

I, Dr.Dissanayake Mudiyanse Jayaratne as the Honourable Minister of Buddhasasana and Religious Affairs by According to the subject matter of sacred area planning and development vested in me, as per the notification issued by His Excellency the President of Democratic Socialist Republic of Sri Lanka Mr.Mahinda Rajapaksa by the Extraordinary Gazette of the Democratic Socialist Republic of Sri Lanka No.1681/3 of 22nd November 2010, declared that, the land area depicted clearly in the schedule as a sacred area and it shall be cited as "Nuwara Eliya St. Francis Saviour Church sacred area", for its long-term security.

COMPOUND AREA OF ST. SAVIOUR CHURCH SACRED AREA

All that divided and defined allotment of land which is bounded as follows, containing in extent 1.5494 Hectares situated in Nuwara Eliya Grama Niladari Division in Minor Division of Oyapalatha Korale in the Divisional Secretariat Division of Nuwara Eliya of the Administrative District of Nuwara Eliya in Central Province depicted as Lot No.A in the Tracing No.NU/NEW/2012/180 dated 19th December 2012 of Surveyor General.



Margins for lot No.A, as follows.

- North by : Canal and holding of Obeysekera ;
East by : Kinan road, St.Francis Saviour road and Long road ;
South by : Kinan road, St.Francis Saviour road and Long road, shopping complex, Udupussellawa road and St.Andrews road ;
West by : St.Andrews road, canal, State Timber Corporation's land, St.Francis Saviour road, foot-path and canal.
