### Land Acquisition Notices

#### THE LAND ACQUISITION ACT (CHAPTER 460)

##### Declaration under Section 5

I, Janaka Bandara Thennakoon, Minister of Lands and Land Development, hereby declare under Sub-section (1) of Section 5 of the Land Acquisition Act, that the lands described below are needed for a public purpose and will be acquired under the provisions of that Act.

Five (05) allotments of below named lands depicted in Advance Tracing No: GAM/DIVU/2013/361 and 31.10.2013, prepared by the Surveyor General, situated in the Villages of Diyagampola and Koradaminna in the Minor Division of Hapitigama Korale in the Divisional Secretary's Division of Divulapitiya, in Gampaha District in Western Province.

##### 01. Lot 'A' – Diyagampolawatta – Extent: 0.0494 Hectare

North: Balance portion of same land, Canal and Lot F, (Canal); East: Lot F (Canal), Lot E and Road (R.D.A); South: Lot E and Road (R.D.A); West: Road (R.D.A) and Balance portion of same land.

##### 02. Lot 'B' – Maussawawatta – Extent: 0.0646 Hectare

North: Lot B, Maussawatta claimed by S. J. Walpita and Road (R.D.A); East: Lot C, Maussawatta claimed by S. J. Walpita and Canal; South: Maussawatta claimed by S. J. Walpita, Canal, Lot E and Road (R.D.A); West: Lot E, Road (R.D.A), Lot F (Canal), Lot G (Canal) and Lot B.

##### 05. Lot 'E' – Extent: 0.0643 Hectare

North: Lot A, Lot F (Canal), Lot G (Canal), Lot D and Road (R.D.A); East: Lot D, Road (R.D.A), Canal and Diyagampolawatta claimed by B. K. T. P. Siriwardhana; South: Diyagampolawatta claimed by B. K. T. P. Siriwardhana and Road (R.D.A); West: Road (R.D.A), Diyagampolawatta claimed by B. K. T. P. Siriwardhana, Lot A and Lot F (Canal).
