### Land Acquisition Notices

#### THE LAND ACQUISITION ACT (CHAPTER 460)

##### Declaration under Section 5

I, Janaka Bandara Thennakoon, Minister of Lands and Land Development hereby declare, under Sub-section (1) of Section 5 of the Land Acquisition Act, that the lands described below are needed for a public purpose and will be acquired under the provisions of that Act.

Five (05) allotments of land called Delgahawatta and Delgahalanda in extent of about 0.0158 Hectare, depicted in the Advance Tracing No. Gam/Kela/2013/236 dated 03.04.2014, prepared by the Superintendent of Surveys of Gampaha District, situated in the Village of Wedikanda in the Minor Division of Adhikari Pattuwa in Kelaniya Divisional Secretary's Division in Gampaha District, Western Province and bounded as follows:

**01. Lot 'A' – Delgahawatta – Extent: About 0.0057 Hectare**

North: Lot Nos. 6 and 7 in Preliminary Plan No. GAM/3894 and Delgahawatta claimed by W. A. Pushpawathi; East: Delgahawatta claimed by W. A. Saroja and Lot D; South: Delgahalanda claimed by A. E. M. Saroja, Lot D and Lot No. 10 in Preliminary Plan No. GAM/3894; West: Lot No. 9 in Preliminary Plan No. 3894.

**04. Lot 'D' – Delgahalanda – Extent: About 0.0043 Hectare**

North: Lot Nos. 9 and 10 in Preliminary Plan No. GAM/3894 and Lot C; East: Delgahalanda claimed by Neisamy Promo and balance portion of same land; South: Balance portion of same land, Delgahalanda claimed by C. M. M. Sarook and Lot E; West: Lot E and Lot Nos. 10 and 11 in Preliminary Plan No. GAM/3894.

**05. Lot 'E' – Delgahalanda – Extent: About 0.0011 Hectare**

North: Lot Nos. 10 and 11 in Preliminary Plan No. GAM/3894 and Lot D; East: Lot D, Delgahalanda claimed by A. E. M. Saroja and balance portion of same land; South: Balance portion of same land; West: Lot No. 11 in Preliminary Plan No. GAM/3894.
