THE LAND ACQUISITION ACT (CHAPTER 460)

Declaration under Section 5

I, Janaka Bandara Thennakoon, Minister of Lands and Land Development hereby declare, under Sub-section (1) of Section 5 of the Land Acquisition Act, that the lands described below are needed for a public purpose and will be acquired under the provisions of that Act.

Three allotments of land called 'Veheragawa Mukalana and Koongahahena' in total extent of about 0.0581 Hectare, in the Advance Tracing No. R/EMB/2013/354 dated 21st October, 2013 prepared by the Surveyor General, situated in the Village of Panamura in Diyapotagam Pattuwa Korale Minor Division in the Divisional Secretary's Division of Embilipitiya in Rathnapura District, Sabaragamuwa Province and bounded as follows:

01. Lot 'A' – Veheragawa Mukalana – Extent: About 0.0496 Hectare
