THE LAND ACQUISITION ACT (CHAPTER 460)

Declaration under Section 5

I, Janaka Bandara Thennakoon, Minister of Lands and Land Development hereby declare, under Sub-section (1) of Section 5 of the Land Acquisition Act, that the servitude over the land described below in the 1st paragraph is needed for a public purpose and will be acquired under the provisions of that Act. It describes in the 2nd paragraph, from which land that the servitude will be acquired.

01. Description of the Servitude – Acquisition of servitude over an additional land for the construction of Access Road to Panamura Ground Reservoir of Kolonna Balangoda Water supply Project.
