THE LAND ACQUISITION ACT (CHAPTER 460)

Notice under Section 7

IT is hereby give notice under Sub-section (1) of Section 7 of the Land Acquisition Act, as amended by the Land Acquisition (Amendment) Act, No. 28 of 1964 that the Government intends to acquire the following land/servitude* which is required for a public purpose.

Description of the Land or Servitude to be acquired:
