I, hereby give notice, under Sub- section (1) of Section 7 of the Land Acquisition Act as Amended by the Land Acquisition (Amendment Act), No. 28 of 1964 that the Government intends to acquire the lands described in the Schedule given below for widening the access road to Kegalle Fair.
