THE LAND ACQUISITION ACT, (CHAPTER 460)

Notice under Section 7

I hereby give notice under Sub-section (1) of Section 7 of the Land Acquisition Act, as amended by the Land Acquisition (Amendment) Act, No. 28 of 1964, that the Government intends to acquire following lands, which is required for the public purpose.
