1. These Regulations may be cited as the Firing Range Regulations 1983

2. 100 meters Small Arms Firing Range at Diyathalawa Air Force Training School (Hereinafter referenced to as "The 100 meters Small Arms Firing Range, at Diyathalawa Air Force Training School) shall not be used for any firing other than Small Arms upto 11.43 mm caliber.

03. Training School. Such notices shall state that a firing range is situated within these points and that when firing is about to commence or is in progress, red flags will be flown by day and all around red lights will be displayed by night at the following points.

Butts and stop Butts Firing Points

At a point ahead of 250 meters in North of Manik Kanda road with an angle of 320 of 100 meters ahead, bounded to the Eastern boundary of the Institute of Surveying and Mapping along the Diyathalawa - Bandarawela main road at a distance of 450 meters.

04. The commander of the Air Force or an Officer authorized by him shall, during the period of half an hour before the commencement of firing at the 100 meters Small Arms Firing Range of Diyathalawa Air Force Training School, cause red flags to be flown by day and all around red lights to be displayed by night at the following points.

Butts and Stop Butts Firing Points

At a point ahead of 250 meters in North of Manikanda road with an angle of 320° of 100 meters ahead, bounded to the eastern boundary of the Institute of Surveying and Mapping along the Diyathalawa - Bandarawela main road at a distance of 450 meters.

05. During the period when read flags are flown or all around red lights are displayed at the 100 meters Small Arms Firing Range at Diyathalawa Air Force Training School, in accordance with regulations 3, no person other than the persons participating in the firing at the 100 meters Small Arms Firing Range at Diyathalawa Air Force Training School shall enter or remain in the area within such range.

06. The Commander of the Air Force or an Officer authorized by him may issue such orders as may be necessary for the safety of persons engaged in the firing at the 100 meters Small Arms Firing Range at Diyathalawa Air Force Training School.

The Commander of the Air Force or an Officer authorized by him shall cause notices to be displayed conspicuously at suitable points along the boundary of the 300 meters Small Arms Firing Range at Morawewa Air Force Camp. Such notices shall state that a firing range is situated within these points and that when firing is about to commence or is in progress, red flags will be flown by day and all around red lights will be displayed by night at the following points.

Butts and stop Butts Firing Points

At the turning point junction to Morawewa Air Force Camp along Anuradhapura main road at a point ahead of the sub-guard room located in the road leading from Wewapara, to Morawewa Air Force Camp.

04. The commander of the Air Force or an Officer authorized by him shall, during the period of half an hour before the commencement of firing at the 300 meters Small Arms Firing Range of Morawewa Air Force Camp, and at the termination of firing, cause red flags to be flown by day and all around red lights to be displayed by night at the following points.

Butts and Stop Butts Firing Points

At the turning point turning point junction to Morawewa Air Force Camp along Anuradhapura main road and at a point ahed of the sub-guard room located in the road leading from Wewapara to Morawewa Air Force Camp.

05. During the period when read flags are flown or all around red lights are displayed at the 300 meters Small Arms Firing Range at Morawewa Air Force Camp, in accordance with regulations 3, no person other than the persons participating in the firing at the 300 meters Small Arms Firing Range at Morawewa Air Force Camp shall enter or remain in the area within such range.

06. The Commander of the Air Force or an Officer authorized by him may issue such orders as may be necessary for the safety of persons engaged in the firing at the 300 meters Small Arms Firing Range at Morawewa Air Force Camp.
