#### THE LAND ACQUISITION ACT (CHAPTER 460)

##### Declaration under Section 5

I, Wijesundara Mudiyanseelage Thilakarathna Bandara Ekanayaka, Minister of Lands, (*Acting*) hereby declare, under Sub-section (1) of Section 5 of the Land Acquisition Act, that the lands described below are needed for a public purpose and will be acquired under the provisions of that Act.
