#### **EXCISE ORDINANCE**

Excise Notification No. 973

#### MINIMUM MONTHLY EXCISE DUTY PAYABLE BY ARRACK AND BEER MANUFACTURERS

BY virtue of the powers vested in me by Section 28(a) read with Section 16(c) of the Excise Ordinance (Chapter 52) as amended from time to time, I, Ravi Karunanayake, Minister of Finance, do by this Notification order that all arrack and beer manufacturers should pay a minimum excise duty of Rs. 200 million per month.

02. Liquor Manufacturing Licenses of all arrack and beer manufacturers who shall not fulfill the above condition with respect to a certain month shall be cancelled with effect from the 01<sup>st</sup> of the subsequent month. This procedure shall be in effect from 01.04.2015.
