### Land Acquisition Notices

#### THE LAND ACQUISITION ACT (CHAPTER 460)

##### Declaration under Section 5

I, Janaka Bandara Thennakoon, Minister of Lands and Land Development, hereby declare under Sub-section (1) of Section 5 of the Land Acquisition Act, that the lands described below are needed for a public purpose and will be acquired under the provisions of that Act.

The allotments of below mentioned lands in total extent of about 0.0339 Hectare, depicted in Tracing No. KU/MWT/2008/130 and dated 26.11.2011, prepared by the Senior Superintendent of Surveys in Kurunegala District, situated in the village of Pilessa Ihalagama in the Minor Division of Gandahe Korale in the Divisional Secretary's Division of Mawathagama in Kurunegala District in the North Western Province and bounded as follows:

**01. Lot 'B' – Pilikadawaththa – Extent: 0.0084 Hectare**

North: Lot A; East: Lot No. 64 of P. P. Ku. 2047 and Lot N 1083 of P. P. 2144; South: Lot N 1083 of P. P. 2144, Lot C and Pilikadawaththa claimed by H. W. Saiman; West: Pilikadawaththa claimed by H. W. Saiman.
