Operators (Female), Ironing Operators (Female), Sewing Machine Operators, Electric Iron

Operators, Issuing Operators (Female), Embroidery Machine/Hand Operators.

Grade IV : Laying out men, Laying out women, Packers, Cellophane Bags and Cardboard Box-Makers,

Unskilled Workers and Stores Labourers.

Grade V : Learners and Apprentices.

The period of apprenticeship in relation to any trade learner or apprentice refferred to above shall be deemed to consist of 156 working days.
