SABARAGAMUWA PROVINCE PROVINCIAL COUNCIL

01. Notification under the section 184 of the Urban Council Ordinance (Chapter 255) and the Provincial Council (Consequential Provisions) Act No.12 of 1989.

Vewelduwe Gnanaprabha Thero, Chairman of the Embilipitiya Urban Council of the Ratnapura District, functioning as the Chairman of the aforesaid Urban Council, as per the powers vested in me by the provisions of Section 184 (1B) (A) (i) of the Urban Council Ordinance (Chapter 255)

04. As the functions of Ven. Vewelduwe Gnanaprabha Thero as the Chairman of the Embilipitiya Urban Council has been temporally suspended with immediate effect under the provisions of section 184 of the Urban Council Ordinance (Chapter 255) and the Provincial Council (Consequential Provisions) Act No.12 of 1989, I do hereby order Mr. W.G. Lalith Dharmakeerthi, Deputy Chairman of the Embilipitiya Urban Council to execute the powers and carry out the tasks thereof, under the section 184 (1B) (A) (i) of the Urban Council Ordinance (Chapter 255) and the Provincial Council (Consequential Provisions) Act No.12 of 1989.
