I, hereby give notice, under Sub-section (1) of Section 7 of the Land Acquisition Act as Amended by the land Acquisition (Amendment) Act, No. 28 of 1964, that the Government indents to acquire the land described below to be utilized for the tanks constructed in Sri Jayawardhanapura area under the Greater Colombo Flood Control and Environment Improvement Project.
