**THE LAND ACQUISITION ACT, (CHAPTER 460)**

**Notice under Section 7**

*My No.:* WGSWD & EIP/ACQ/DW/04.  
*Land Min's Ref No.:* 4/3/10/2012/LRB/98.

I, hereby give notice, under Sub-section (1) of Section 7 of the Land Acquisition Act as Amended by the Land Acquisition (Amendment) Act, No. 28 of 1964, that the Government intends to acquire land located between Dehiwala-Maharagama (119) bus route and Maharagama-Moratuwa (192) bus route to create a water reserve to collect storm water temporarily in Attidiya, Bellanthara paddy field under Weras Ganga Water Drainage and Environment Improvement Project.

*Description of the land to be acquired:*

An allotment of land in total extent of 1.9251 Hectare, depicted as Lot No. 01 in the Preliminary Plan No. 9465 dated 27.03.2015 prepared by the Surveyor General situated in the village called Bellanthara in the Grama Niladhari Division No. 535/A of Bellanwila in the Divisional Secretary's Division of Kesbewa in Colombo District of the Western Province.
