RULES

01. These Regulations shall be called and known as Regulations in respect of payment of allowances to Mayors, Deputy Mayors and Members of the Municipal Councils in Central Province.
02. An allowance as mentioned below may be payable to the Mayors, Deputy Mayors and Members elected to the Municipal Councils of the Central Province, effective from 01st of November, 2014.

Mayor	– Rs. 30,000.00
Deputy Mayor	– Rs. 25,000.00
Member	– Rs. 20,000.00



- 03.1. The Mayors, Deputy Mayors and Members of the Municipal Councils shall not entitle for obtaining these allowances under following instances.
- i. Failure to attend Council meetings and committee meetings without the approval of the Council in respect of the relevant month for which allowances are payable.
 - ii. Going abroad for private purpose, and outside the functions of the Councils.
 - iii. Being in custody or imprisonment in respect of any criminal charges.
- 03.2. A Mayor, Deputy Mayor or a Member shall not lose his right to claim allowances for failure to attend Council meetings or committee meetings, when they are engaged on any official function with the formal approval, irrespective of whatever mentioned in Sub section (i) of Section 1 of this Regulation.
