LAND REFORM COMMISSION NOTICES

LAND REFORM LAW, No. 1 OF 1972

Order under Section 22 (1) f

BY VIRTUE of the powers vested in me by paragraph (f) Subsection (1) of section 22 of Land Reform Law, No. 1 of 1972 of the National State Assembly as amended by No. 18 of 1986, No. 14 of 1986, No. 39 of 1981 No. 14 of 1981, and No. 39 of 1975 I, The minister of Lands M. K. A. D. S. Gunawardena, do by this Order declare that:-

- (a) the agricultural lands specified in Column II to this Order shall vest in the persons whose names are specified in Column I of the Schedule to this Order;
- (b) the agricultural lands specified in the corresponding entry in Column II of the Schedule to this Order were owned by the persons whose names appear in Column I of the Schedule to this order and that such agricultural land were included in the extent of land deemed to be owned by the head of the family of which such persons were members;
- (c) the persons whose names appear in Column I of the Schedule to this Order were under eighteen years of age at the time of the imposition of the ceiling on agricultural land in terms of the aforesaid Law;
- (d) the agricultural lands specified in Column II of the Schedule here to have not been alienated to any person under section 22 of the said Law; and
- (e) no compensation has been paid in respect of such agricultural lands under Section 28 of the said law;
- (f) It is declared that Government *extra ordinary Gazette* Notification No. 1568/15 and dated 23rd September 2008 in the Democratic Socialist Republic of Sri Lanka is here by amended by the said Law.
