**Order under Section 64(1)**

#### SCHEDULE

Contents of Voluntary Transfer Scheme Section 61 (1)

- (a) The following movable and immovable property to be transferred to and vested in the National Water Supply and Drainage Board to wit,
  - (i) All lands, buildings pipelines, all mechanical and electrical machinery and equipment fixtures and all spares accessories and stores items required for the implementation and maintenance of all intakes refineries, pressure and balancing tank and pumping station of the Hakmana Water Supply Scheme listed in schedule I.
  - (ii) Servitude over pipelines, spares accessories and stores items along with main pipelines and distribution pipeline required for the operation and maintenance of water distribution network at the Hakmana Water Supply Scheme within the area of authority of the Pradeshiya Sabha Hakmana.

- (b) The rights, obligations and liabilities of the Pradeshiya Sabha Hakmana together with any contract the council has entered into in connection with design, supply, installation, constructions, operation and maintenance with respect of the aforesaid property will also be transferred to the Board;
- (c) All agreements entered into with water consumers with regard to conditions of the use and supply of water services and payment to obtain such services will also be transferred to the Board;
- (d) The assets of these facilities valued at Rs. 3,831,730/- (Rupees Three million Eight Hundred and Thirty One Thousand and Seven Hundred Thirty) will be provided on grant to the Board by the Government.
- (e) All agreements entered into by the Pradeshiya Sabha Hakmana in connection with water supply will also be continued and honored by the Board. The above transfer will come into effect from the date of publication of this notice.
