#### STATUTORY DETERMINATION UNDER SECTION 19 OF THE LAND REFORM LAW, No. 1 OF 1972

WHEREAS a Statutory Declaration under Section 18 of the Law has been made by Mrs. Dunuwila Sriyani Sujatha Ranasinghe of No. 74, Rajapihilla Mawatha, Kandy, the Land Reform Commission by virtue of the powers vested in it under Section 19 of the Law, has made a statutory determination specifying the portion of agricultural land owned by the statutory lessee which she shall be allowed to retain.
