TOWN AND COUNTRY PLANNING ORDINANCE (CHAPTER 269)

Order under Section 6(2)(b) and Section 21(2)(b)

BY VIRTUE of the powers vested in me by Section 6(2)(b) and Section 21(2)(b) of the Town and Country Planning Ordinance (Chapter 269), I, Ranil Wickramasinghe, Minister of Policy Planning, Economic Affairs, Child, Youth and Cultural Affairs do by this order :-

- (a) declare that the area of land specified in the Schedule hereto shall be an Urban Development Area for the purpose of the aforesaid Ordinance and shall be called the “Battaramulla Batapotha Sri Sudarshanarama Purana Viharaya Sacred Area” and
- (b) direct that an outline scheme shall be prepared for the whole of the area declared to be “Battaramulla Batapotha Sri Sudarshanarama Purana Viharaya Sacred Area”.
