#### THE LAND ACQUISITION ACT (CHAPTER 460)

#### **Declaration under Section 5**

I, John Anthony Emmanuel Amarathunga, Hon, Minister of Lands hereby declare, under Sub-section (1) of Section 5 of the Land Acquisition Act, that the land, described below are needed for a public purpose and will be acquired under the provisions of that Act.
