I hereby give notice, under sub-section (1) of section 7 of the Land Acquisition Act, as amended by the Land Acquisition (Amendment) Act, No.28 of 1964, that the Government intends to acquire the abandon paddy field described below and located between Pitawella Road" Boralesgamuwa and Borupona Bridge to create a water reserve under Weras Ganga Storm Water Drainage and Environment Improvement Project.
