Notice under Section 7

I, hereby give notice under Sub-section (1) of Section 7 of the Land Acquisition Act No. 28 of 1964 (Amendment) that the Government intends to acquire the following land/servitude which is required for a public purpose.

Description of the land or servitude to be acquired:
