PART I : SECTION (I) — GENERAL

THE URBAN DEVELOPMENT PROJECTS (SPECIAL PROVISIONS) ACT No. 2 OF 1980

Order under Section 2

BY virtue of powers vested in me under Section 2 of the Urban Development Projects (Special Provisions) Act No. 2 of 1980, I, Maithripala Sirisena, President of the Democratic Socialist Republic of Sri Lanka upon the recommendation of the Minister-in-Charge of the subject of Ministry of Megapolis and Western Development, being of the opinion that the lands specified in the schedules I and II hereto are urgently required for the purposes of mix development Housing Project and resettlement of underserved settlers respectively do by this order, declare that the said lands are required for such purposes.

One (1) allotment of land, Piliyandala depicted as Lot No. 1 in Advanced Tracing No. Co/KSB/2017/150 dated 29.05.2017 prepared by the Surveyor General containing in extent of 12 A-0R-28.3P (4.9277 Ha.) situated in Suwarapola village within the Divisional Secretariat Division of Kesbewa in the District of Colombo, Western Province.
