**A Statute to Amend the Appropriation Statute No. 04 of 2015 as Amended by Appropriation Statute No. 02 of 2016, Statute No. 05 of 2016, and Statute No. 03 of 2017, of the Sabaragamuwa Provincial Council of the Democratic Socialist Republic of Sri Lanka**

1. This Statute may be cited as the Sabaragamuwa Provincial Council Appropriation (Amendment) Statute No. 05 of 2017, and shall come in to operation of the date of Receiving the assent of the Governor of the Sabaragamuwa Province.
