A STATUTE TO AMEND THE APPROPRIATION STATUTE NO. 05 OF 2011 AS AMENDED BY APPROPRIATION STATUTE NO. 02 OF 2012, STATUTE NO. 03 OF 2013, No. 09 OF 2014 AND STATUTE NO. 05 OF 2015 OF THE SABARAGAMUWA PROVINCIAL COUNCIL OF THE DEMOCRATIC SOCIALIST REPUBLIC OF SRI LANKA

1. This Statute may be cited as the Sabaragamuwa Provincial Council Appropriation (Amendment) Statute No. 06 of 2017, and shall come in to operation of the date of receiving the assent of the Governor of the Sabaragamuwa Province.



2. The limits mentioned in the Advance Account namely 8103, 8313 in the Second Schedule of the Appropriation Account No. 05 of 2011 as amended by Appropriation Statute Nos. 02 of 2012, No. 03 of 2013, No. 09 of 2014 and No. 05 of 2015, is hereby amended as per the first schedule hereof.
