A STATUTE TO AMEND THE APPROPRIATION STATUTE No. 02 OF 2008 AS AMENDED BY APPROPRIATION STATUTE No. 04 OF 2009 AND STATUTE No. 07 OF 2009 OF THE SABARAGAMUWA PROVINCIAL COUNCIL OF THE DEMOCRATIC SOCIALIST REPUBLIC OF SRI LANKA

1. This Statute may be cited as the Sabaragamuwa Provincial Council Appropriation (Amendment) Statute No. 09 of 2017, and shall come into operation of the date of receiving the assent of the Governor of the Sabaragamuwa Province.
2. The limits mentioned in the Advance Account namely 8102, 8103, 8332 and 8333 in the Second Schedule of the Appropriation Account No. 02 of 2008 as amended by Appropriation Statute No. 04 of 2009 and No. 07 of 2009, is hereby amended as per the first schedule hereof.
