A Statute to Amend the Appropriation Statute No. 01 of 2007 as Amended by Appropriation Statute No. 03 of 2008, and Statute No. 05 of 2014, of the Sabaragmauwa Provincial Council of the Democratic Socialist Republic of Sri Lanka
