SPECIAL COMMODITY LEVY ACT, No. 48 OF 2007

Order under Section 2

BY virtue of the powers vested in me under Section 2 of the Special Commodity Levy Act, No. 48 of 2007, I, Mangala Samaraweera, Minister of Finance and Mass Media of the Democratic Socialist Republic of Sri Lanka, do by this order impose in respect of the list of commodities specified in Column I of the Schedule hereto a Special Commodity Levy at the rates specified in the corresponding entries in Column II of that Schedule.

This Order shall be valid for a period of 06 months commencing from December 14, 2017, subject to provisions of Sub Section (3) of Section 2 of the Special Commodity Levy Act, No. 48 of 2007.

The Order made under Section 2 of the Special Commodity Levy Act, No. 48 of 2007 and published in the *Extraordinary Gazette Notification* No. 2044/6 of 06.11.2017 in respect of Sail Fish (*Istiophorus platypterus*) and Marlin Fish (*Makaira spp*) classifiable under the HS Code 0303.89.90 and *Extraordinary Gazette Notification* No. 2044/25 of 07.11.2017 in respect of Thora Fish (Narrow - barred Spanish mackerel/*Scomberomorus commerson*) classifiable under the HS Code 0303.89.90 are hereby resinded with effect from December 14, 2017.
