Supplmentary Provision for Appropriation Statute No. 12 of 2017

A statute to provide Supplementary Provisions to previously approved expenditure of the Nothern Provincial Council for the financial year 2017 by the Honourable Governor on the 26th day of December 2016 in accordance to First Schedule to this statute and to make payments by way of advance out of the Northern Provincial Council funds or monies to provide for the refund of such monies to the Nothern Provincial Council funds and to make provisions for matters connected therewith or incidental thereto.

Short title

Be it enacted by the Northern Provincial Council as follows.

Appropriation, supplementary provision, for financial year 2017

- 1. This Statute may be cited as the Supplementary Provision for Appropriation Statute No. 12 of 2017.
- 2. Without prejudice to any other Law which authorizes for any such expenditure, the expenditure of the Northern Provincial Council during the financial year beginning from 1st January 2017 and ending on 31st December 2017 referred to as the "Financial year 2017" in this Statute re-allocation of Rupees Twenty two million and five hundred thousand only (Rs. 22,500,000) from the expenditure the Honourable Governor approved on the 26th December 2016 and to the limits stated in the First Schedule of this Statute shall be met;
 - A) From the Nothern Provincial Council funds or monies, or
 - B) From the allocation of funds allocated in accordance to Article 154 R of the Constitution of the Democratic Socialist Republic of Sri Lanka and any other funds allotted or granted by the Government of Democratic Socialist Republic of Sri Lanka.
