ORDER

- 1) This order is cited as the order with regard to the payment of Stamp Duty under the Section 40(2) of the Finance Statute No. 13 of 1990 as amended by No. 7 of 1991 Finance Statute (Amendment) of the North Central Provincial Council and shall come into operation on 01st January 2018.
- 2) It is hereby required to use the certificate obtained by paying money to the bank in terms of Section 40(2) of the Finance Statute No. 13 of 1990 of the North Central Provincial Council in place of using adhesive stamps.
- 3) The amount payable for stamp duty shall be paid to any People's Bank in Sri Lanka to the Account Number 008-1-001-2-1724458 in accordance with the following forms.
